

REPORT OF THE GOVERNING BODY OF THE NATIONAL INSTITUTE OF PUBLIC FINANCE AND POLICY FOR THE FINANCIAL YEAR 1978-79

Introduction

The year 1978-79 is the third year of operation of the Institute. During this year, the Institute continued and expanded substantially its research programmes and consultancy activities on behalf of the State governments. The most notable new developments are the beginnings made with training programmes, the research assistance given to the Seventh Finance Commission and the accelerated development of the Institute's library.

As on March 31, 1979, the Institute had on its rolls 16 professional staff members including the Director; in addition there were also 8 temporary research investigators attached to various projects. The list of faculty members other than temporary research investigators is given in Annexure 1. During the year the professional staff position was strengthened by the recruitment of one senior fellow, one senior tax analyst and one young economist.

It may be recalled that during the year 1977 - 78 the Reserve Bank of India had signified its willingness to endow a chair in Fiscal Policy at the Institute and that it had not been possible during that year to locate a suitable candidate. In accordance with the request made by the Selection Committee which had met on April 29, 1978, the Director explored various possibilities and contacted a number of potential candidates. We are glad to report that, on the recommendation of the Selection Committee, an offer of appointment to the chair in Fiscal Policy has been made to Dr. A. Bagchi, Director, Fiscal Policy Cell, Department of Economic Affairs, Ministry of Finance. The Department of Economic Affairs, have agreed to release Dr. Bagchi as soon as his present assignment as Member-Secretary of the Committee on the Tax Impact on Production is completed. Dr. Bagchi has accepted the offer and is expected to join duty by about the end of September 1979.

Research Activities

In the current year some research projects undertaken during the previous year were completed and certain important new ones were started.

It was stated in the report for the year 1977-78 that work had been started on a project dealing with Major Issues in Federal Finance. A research team of the Institute worked

on this project and a detailed theoretical-cum-empirical paper was prepared by the middle of the year 1978, which reviewed the principles and impact of the recommendations of the first six Finance Commissions and highlighted the major issues facing the Seventh Commission. This paper was submitted as the basic discussion paper to a Seminar on Major Issues in Federal Finance organised by the Institute on July 1 and 2, 1978, which was sponsored by the ICSSR.

The study on the Impact of Personal Income Tax was completed during this year and a report was brought out. Copies of the report have been circulated to interested scholars, senior officials of the Central Board of Direct Taxes and all the Members of the General Body of the Institute. The study would be revised and published shortly. Significant progress has been made in regard to the project on Corporate Taxation. One section of the study containing a discussion of the theory of Corporate Profits Taxation and of Alternative Systems of Taxing Corporate Profits has been completed.

With the completion of several of the projects undertaken earlier, certain important new projects were taken up during the year under reference. The World Bank has sponsored a project on the Measurement of Comparative Tax Effort by Indian States. This project covers 15 States and all the major taxes levied by them. In measuring tax effort, by agreement with the sponsors, we are employing what has been called the Representative Tax System Approach. This project is nearing completion. The second major new project undertaken during the year, is on the Growth of Government Expenditure. This study would enquire into the sources of growth of government expenditure as well as examine the commodity composition of public expenditure. Making use of the input-output table, the study would seek to measure the sectoral impact of increases in government expenditure. Initially, attention is being confined to Central government expenditure. In course of time, the study would be extended to cover expenditure by a few State governments. The Institute has submitted the study for sponsorship to the Planning Commission; however, work on the project has already been started.


As desired by Members at the General Body meeting held on August 19, 1978, the titles of projects already completed, on-going projects and projects proposed to be undertaken by the Institute are given in Annexure II.

A seminar paper on "Financing of Capital Formation in the Government Sector in India: 1950-51 to 1975-76" was prepared by the Institute and submitted to the Conference of the Indian Association for Research in National Income and Wealth, held in Trivandrum in December 1978. This paper is being published after revision in The Journal of Income and Wealth which is the official journal of the Association.

Soon after the announcement of the Union Budget for the financial year 1979-80, the staff of the Institute prepared an empirical paper on "The Impact of the Union Budget". This paper was submitted to a joint symposium on the Union Budget organised by the Institute and the NCAER. One section of this paper dealt with the impact of the budget deficit on money supply and prices. This part was subsequently expanded and issued as a working paper entitled "An Assessment of the Impact of the Union Budget 1979-80".

The Government of Nigeria had requested the Institute to prepare a paper on the Indian experience in curbing tax evasion and tax avoidance, specially by privately employed professional persons and illiterate traders and businessmen with small means. The External Affairs Ministry, Government of India, gave consent to the Institute preparing this paper on behalf of the Federal Government of Nigeria. A fairly detailed paper on "Curbing Tax Evasion and Tax Avoidance - The Indian Experience" was prepared and submitted to the Nigerian High Commission, New Delhi by the end of the year.

Work for the State Governments

In this area the assignments of the Institute have expanded fairly rapidly. The survey of the tax system of Assam, undertaken in the year 1977-78, was completed and a detailed report was submitted to the Government containing recommendations for major reforms of the tax structure and improvement in tax administration. Permission from the State government is awaited for the publication of this report. Secondly, it may be recalled that a study of the sales tax system of the State had been entrusted to the Institute by the Government of Bihar sometime in February 1978. The study has now been completed and a draft report has been submitted to the Commissioner of Commercial Taxes. The report would be finalised in the light of comments received from the Commercial Taxes Department. Thirdly, the Institute is doing a considerable amount of background research work in connection with the work of Gujarat Taxation Enquiry Commission of which the Director of the Institute, Dr. R. J. Chelliah, is the Chairman. The work of the Gujarat Taxation Enquiry Commission has moved ahead according to plans and is likely to be completed within a period of about four months. Fourthly, the Government of Uttar Pradesh has constituted a Taxation Enquiry Committee under the Chairmanship of Dr. R.J. Chelliah, Dr. K.N. Reddy, Senior Fellow in the Institute, has been appointed one of the members of the Committee so that he could oversee the research needed in connection with the work of the Committee. It is expected that the measurement of incidence of State taxes in Uttar Pradesh would be undertaken at the Institute on behalf of the Committee.

One of the objectives of the Institute is to help State governments build up a comprehensive information system for their Taxation Departments. In the four studies undertaken or being undertaken for the State governments, special attention has been paid to this aspect and detailed recommendations have been made on the setting up of an information system. In furtherance of this objective, the Institute organised a Workshop on the "Computerisation of Sales Tax Data" on October 12-13, 1978 in the premises of the Institute of Economic Growth. A basic paper was submitted by the Institute to this workshop. The workshop was well attended and elicited keen interest from the representatives of several State governments. The proceedings of the workshop, together with the discussion paper prepared by the Institute, would be soon brought out and circulated to all State governments.

It had been stated in the report for the year 1977-78 that the Department of Personnel and Administrative Reforms, Ministry of Home Affairs, had requested the Institute, at the instance of the Planning Commission, to organise a Workshop for State government officials on

"The Techniques of Budgetary Projections". We are glad to report that a workshop on this subject was held in Delhi in February 1979. In addition to lectures by the staff of the Institute and excercise sessions, guest lectures were delivered by eminent scholars and experienced persons such as Prof. Raj Krishna, Prof. I. S. Gulati, Dr. B. Bhattacharya and Shri B. Sivaraman, Joint Secretary, Seventh Finance Commission. This workshop could accommodate officers only from about half of the States. To accommodate officials from the other States, a second workshop was scheduled to be held at the beginning of the year 1979-80*.

Finally, work is on hand for the compilation of comparative data on tax rates and tax structure in the different States on the basis of the information contained in the memoranda submitted by the States to the Seventh Finance Commission. It is expected that the first comparative statement on sales taxation would be brought out within the next three months.

Visiting Professors

Prof. I. S. Gulati continues to be a Visiting Professor of the Institute. He visits the Institute from time to time, gives seminars and participates in our research activities by giving guidance and commenting on research papers, etc. Dr. P. Nagarajan, Visiting professor from the University of Prince Edward Island, Canada, came to the Institute in November 1977, and was with us till the end of August 1978. Dr. Nagarajan was conducting research on "The Growth Pattern of Government Expenditure in India".

Exchange of Scholars and Collaborative Research

During the months of October/November 1978, the Director of the Institute went on a tour of a number of centres of higher learning in the U.S.A., Canada and the U.K., specialising in the field of Public Finance. (A separate report on the tour has been submitted to the Governing Body.) During this tour, the Director discussed possibilities of training, collaborative research and exchange of scholars with a number of Universities. The Maxwell School of Business at the University of Syracuse and the Institute of Economic and Social Research at the University of York seem to offer the greatest potential for exchange of scholars and collaborative work. The Institute would like to develop research work in the field of state and local finances in collaboration with the Syracuse University. The Ford Foundation grant would enable the Institute to send one or two members of staff for training and post-doctoral work at this University. Also it would be possible to invite renowned scholars to come and spend a few weeks with us. Under this programme, Prof. Larry Schroeder of Syracuse University is expected to visit the Institute and stay with us for about three weeks in the month of May 1979.

Seminars

The programme of seminars given by visiting scholars or the Institute's own staff was continued. These seminars are intended mainly for the benefit of the Institute's staff. However, whenever a distinguished scholar comes to deliver a talk or lead a discussion on some important

subject, we also invite people from other institutions such as the Universities and Government departments. The details of the regular seminars given during the year are given in Annexure III One of the highlights of the programme during this year was the seminar given by Lady Ursula Hicks from Linacre College, Oxford, a well known international authority on Problems of Federal Finance. In addition to the regular seminars, we organised two joint Symposia. The first one was organised jointly with the NCAER on the Union Budget for 1979-80. The second one was jointly organised with the Institute of Economic Growth on the Seventh Finance Commission's Recommendations. At both these Symposia, in addition to the staff of the Institute and the collaborating Institutions concerned, eminent scholars from outside were also invited to participate.

Library

During the year, nearly a thousand volumes of books, reports and other publications, Indian and foreign, relating to Public Finance, Public Policy and allied subjects were added to the holdings of the Library. As of now, 70 periodicals including loose-leaf series are being received in the Library. (The list of Journals received in the Library is given in Annexure IV.) Our books, reports, reprints and mimeographed papers are being sent on an exchange basis to well known Institutions, both in India and other countries. Prominent Institutions abroad with which we have such an exchange arrangement are the Institute for Policy Analysis, University of Toronto, Canada; Fiscal Affairs Department, International Monetary Fund, Washington D. C.; Institute of Economic and Social Research, University of York, the U. K.; The Maxwell School of Business, Syracuse University, the U. S. A.; The Department of Economics, Erasmus University, Rotterdam, Netherlands; and Centre for Research on Federal Financial Relations, The Australian National University, Canberra, Australia.

Corporate Membership

The strength of corporate members has not changed significantly during the year. The Government of Madhya Pradesh has become a life corporate member by paying an additional amount of Rs. 18,000. With the addition of Madhya Pradesh, we have now five Life Corporate Members. The Government of Arunachal Pradesh has recently written to us stating that they wish to discontinue their membership. A list of Corporate Members as on 31-3-1979 is given in Annexure V.

Composition of the Governing Body

Certain changes have taken place in the composition of the Governing Body during the year. As the two-year term of representation of Punjab, Rajasthan and Uttar Pradesh was over by the end of 1978 - 79, they were replaced on the Governing Body by the Governments of Andhra Pradesh, Karnataka and West Bengal, who had become sponsoring members after the former three Governments. Shri B. P. R. Vithal, Secretary, Finance Department, Andhra Pradesh; Shri M. K. Venkatesan, Financial Commissioner and Secretary, Karnataka and Shri M. G. Kutty, Secretary, Finance Department, West Bengal have been nominated by their respective

Governments to serve on the Institute's Governing Body.

Shri P. J. Fernandes, having been transferred, Shri G. Ramachandran, his successor in the office of Finance Secretary, Government of India, became an ex-officio member of the Governing Body. Also during the year, Dr. V. B. Kadam, Adviser and Officer-in-charge of the Economic Department, Reserve Bank of India has been nominated as a member of the Governing Body in place of Dr. A. K. Banerjee, who had retired. During this year, Shri Pravinchandra V. Gandhi represented the Federation of Indian Chambers of Commerce and Industry and Shri F. A. A. Jasdanwalla represented the Associated Chambers of Commerce and Industry of India on the Governing Body. A list of the Governing Body members is given in Annexure VI.

Endowment Fund

During the year a sum of Rs. 3,50,000 was received as payment towards the Endowment Fund raising its level to Rs. 48,00,000. Contributions received during the year consist of the second instalment from the Government of Tamil Nadu amounting Rs. 1, 50,000 and the second instalment of Rs. 2,00,000 from the Industrial Credit and Investment Corporation of India, Limited.

In accordance with the decision taken by the Governing Body, a sum of Rs. 1,50,000 was transferred to the Building Fund Account to meet part of the payment towards purchase of land for the Institute's building. After transferring this amount to the building fund, the balance in the endowment fund as on March 31, 1979 was Rs. 46,50,000. During the year a sum of Rs. 30,000 was received from some members of the Associated Chambers of Commerce and Industry of India, thereby raising the latter's contribution to Rs. 4,65,750 against the total promised contribution of Rs. 5,00,000. This amount has been placed separately in the Scientific Research Fund.

Ford Foundation Grant

During this year, out of a total non-recurring grant of US \$ 2,00,000 sanctioned by the Ford Foundation, the Institute obtained release of the following amounts:

In Rupees 2, 38, 794
In US \$ 50,000

As on March 31, 1979, we had spent out of the grant the equivalent of US \$ 31,491. Detailed break-up of utilisation of the grant is given in Annexure VII.

Building for the Institute

For supervising the work of construction of the building of the Institute and for taking all necessary steps in that connection, the Governing Body appointed a Building Committee consisting of Dr. B. K. Madan, Chairman, Shri I. Z. Bhatty, Shri R. Krishnamurthi, (representative

of the Finance Ministry.), a representative of the Associated Chambers of Commerce & Industry of India, the Chief Architect to the Government of India (representative of the Ministry of Works and Housing), and the Director of the Institute as convener.

The Building Committee has taken steps to appoint an architect for the Institute's building. An advertisement was issued in two leading newspapers regarding the work of the building of the Institute and inviting applications from well established architect firms, preferably based in Delhi. 35 responses were received. After proper scrutiny the Building Committee appointed a Sub-Committee to interview four firms of architects. On the recommendation of the Sub-Committee which interviewed the representatives of these firms, the Building Committee finally selected M/s. Raj Rewal Associates to be the architects for the first phase of Institute's building. Currently, the architect is preparing the preliminary sketches to be shown to the Building Committee.

Conclusion

The Governing Body is happy to note that during the third year of operation, the Institute has been able to substantially expand its research and consultancy activitities. It has also noted with satisfaction that the Institute has made a promising beginning with its training programme for State government officials. The Institute may be said to have demonstrated its usefulness to the various member governments.
