

REPORT OF THE GOVERNING BODY OF THE NATIONAL INSTITUTE OF PUBLIC FINANCE AND POLICY FOR THE YEAR 1989-90

HIGHLIGHTS

Little steps, giant strides - that perhaps best describes the progress made by the Institute in the last fourteen years. The year under review, 1989-90, was the fourteenth year of the Institute's service to the nation in the highly specialised area of public finance and policy. As in the past years, the Institute kept up its endeavour to fulfil the aims of the founding fathers by undertaking studies on the fiscal system and evaluation of the effect of the budgetary and related policies on the economy, training public servants at different levels and taking up research and consultancy in the area of its specialisation.

Projects/Studies Completed

During the year the Institute completed about 20 projects and brought out 13 working papers while nearly 30 projects were in progress (list at Annexure I). This brings the total number of projects completed during the fourteen years of the Institute's life to 82 and of working papers to 74. These products are the outcome of the commitment of the Institute's staff to their responsibilities as also their academic interest and interaction with policy making departments and bodies in government and semi-government agencies and with fellow researchers in other academic institutions in India and abroad.

Seminars, Symposia and Conferences

Among the outstanding events of the year at the Institute pride of place goes to the Conference of the International Seminar in Public Economics (ISPE) held in January, 1990, in which several leading experts of the world presented papers on and discussed the role of "Public Finance in the Planning Process". Earlier, in September 1989, the Institute had hosted another international seminar sponsored by ESCAP and the Planning Commission. The theme was "Fiscal Decentralisation, Resource Mobilisation and Effective Use of National Resources in Development". The seminar was inaugurated by the then Union Minister of Planning and Programme Implementation, Shri Madhavsinh Solanki. Besides ESCAP, over a dozen countries including India represented by the Institute participated.

The Institute also organised several national level seminars, symposia, workshops and one-day round table discussions. These included a seminar on Revision of UN System of National Accounts (UNSNA) jointly organised by the Institute and the Indian Association for Research in National Income and Wealth (IARNIW) to discuss the proposals being considered at the international level for revision of the UN System of National Accounts (UNSNA). Besides, there was a one-day workshop on informal credit markets in India, a round table discussion on the extent and impact of liberalisation and a symposium on sales taxation of works contracts attended by Commissioners of Sales Tax/Commercial Taxes of the States at which some eminent experts were invited to speak. Several in-house seminars/symposia were given by the Institute's own academic staff and also scholars invited from outside (vide Annexure II). A special programme of in-house seminars for faculty improvement was started during the year. The programme has evoked great interest and enthusiasm among faculty members and researchers at all levels. Details of this programme are in Annexure II.

Faculty Changes

There were several notable changes in the staff during the year. While some left the Institute after completing their assignments, some others left seeking better prospects elsewhere. It was home coming for Dr. Raja J Chelliah, who returned to the Institute as Professor of Eminence (Honorary) after completing his tenure as a distinguished Member of the Planning Commission and the Ninth Finance Commission.

Activities of Special Research Units

The four special research units that were set up in the Institute in the last three years were fully functional during the year.

The Direct Taxes Cell, set up in 1987-88 with support from the Central Board of Direct Taxes is now engaged in several policy oriented studies and research programmes in the field of direct taxation. It has already completed several studies covering economic, legal and administrative issues in direct taxation and has brought out a profile of direct tax systems of other countries.

Work in the other three research units set up for undertaking studies in (i) State Finances, (ii) Housing and Urban Finance, and (iii) Macro-economic and Industrial Policy has also been going on in full swing and has yielded several useful reports and studies.

The State Finances Unit, set up with the generous assistance of the State Governments of Assam, Gujarat, Jammu and Kashmir, Karnataka, Kerala, Maharashtra, Meghalaya, Mizoram, Orissa, Tamii Nadu and West Bengal, has been actively pursuing a programme of data-based studies which would eventually enable the participating State Governments to compare their fiscal performance with each other, undertake fruitful tax reform and better fiscal planning as well as coordinate their tax systems and fiscal administration with those of other States. It is also trying to provide a comparative picture of the States' finances both on the revenue and the expenditure side. This unit has been providing services to the State Finance Departments in various forms like furnishing data on public finance and related information on request.

In the Housing and Urban Finance Unit a preliminary draft of "Housing as an Industry" was finalised

during the year. Two other studies relating to housing are making good progress. The Unit was set up with a Chair endowed by the Housing Development Finance Corporation (HDFC). The projects initiated in this Unit have acquired significance in view of the urgency of finding viable solutions to the severe shelter problem in the country.

The Macro-economic and Industrial Policy Unit set up with support from Ford Foundation had a large crop of output during the year in the form of working papers and studies and some of them were presented at a round table discussion attended by eminent academicians and senior policy makers in the government.

In addition to the existing RBI Chair on Fiscal Policy, the Institute has a Chair in Economic Policy endowed by the State Bank of India which was also operational for most of the year and a number of studies/papers were completed within a short time.

Training Programmes

As in the past, the Institute continued to organise training programmes which were equally varied and useful. During the reporting period, 1989-90, the Institute conducted four training programmes. Notable among the training courses were two training programmes sponsored by the Department of Personnel and Training, Government of India. In the first course which was on Fiscal Analysis and Budgetary Planning, 27 middle level officers of Central and State governments participated. In the second, the focus was on Finance and Budget. It was organised specially for officers of the State of Jammu and Kashmir Two Advanced Training Courses in Sales Taxation were also held for senior officers of Sales Tax/Commercial Taxes Departments of the States as in the past years.

Newsletter

Another notable event of the year was the publication of a newsletter fulfilling a long felt need. Started in October, 1989, the newsletter will try to provide on a half yearly basis an idea of the activities going on in the Institute and also the main findings of important projects/studies completed. A section of the newsletter will be devoted entirely to data or studies which would be of interest to the States.

Computer Unit and Library

The Institute's Computer Unit and Library continued to fulfill the vital support functions that they were called upon to perform keeping up with the expansion in the volume of work that has taken place in the last few years. The strengthened Computer Unit is now going ahead with a programme of consolidating and systematising its data bank especially in the field of government finances. The library is now on the way to assuming the role of a repository of the fast growing literature on Public Economics. The Institute is indeed grateful to the Ministry of Finance and the Planning Commission for their continuing generous support for the development of these two essential Units. During the year under review, the library acquired one photocopier which will be at the service of the users of library. It has already acquired microfiche equipment.

Ford Foundation Endowment

Mention must be made also of the generous grant extended by the Ford Foundation for creating an endowment fund to assure regular support for the library and also enable the Institute's scholars to participate in seminars/conferences abroad and for inviting foreign scholars to visit the Institute from time to time.

Post-doctoral Fellowship Programme

During 1988-89, the Institute had undertaken to administer an overseas post-doctoral fellowship programme of the Ford Foundation for Indian scholars in economics. The programme became fully operational during the year and two rounds of selection of scholars were completed by 1989-90. The selections were made out of applications invited through advertisement on an all India basis and screened by a selection panel with five distinguished academicians who also interviewed the candidates shortlisted out of the applications received. Fellowships have been awarded in all to nine scholars drawn from different parts of the country, of whom two belong to the Institute.

NIPFP Building Complex

The construction of 9 faculty flats including the Director's residence is nearing completion. The flats are likely to be ready for occupation during the next financial year.

A fuller report on the events and activities of the year are given below.

FACULTY CHANGES

Prof Raja J Chelliah, returned to the Institute in January 1990 and joined as Professor of Eminence (Hony.) after having served with distinction as a Member of Planning Commission and also the Ninth Finance Commission. The Institute is privileged to have the benefit of his guidance and active participation in its academic activities once again.

Dr Sudipto Mundle, Senior Fellow, who was on leave from the Institute from September 1989 to March 1990, has returned to the Institute. During the leave period, he spent two terms as the First Joan Robinson Memorial Lecturer in the Faculty of Economics and Politics at the University of Cambridge.

Dr M Govinda Rao, Senior Fellow, rejoined the Institute in December 1989 after serving the Ninth Finance Commission as its Economic Advisor on deputation.

Dr Pulin B Nayak, who spent a year as Reserve Bank of India Professor at the Institute has returned to Delhi School of Economics.

Prof Amal Sanyal has returned to his parent department at the Jawaharlal Nehru University after completing his tenure as the first incumbent of the State Bank of India Chair at the Institute.

Dr V B Tulasidhar is away at the Department of International Health, John Hopkins University, USA on a fellowship under the International Health Programme.

Dr Gopinath Pradhan is visiting the Economics Department at Boston University, USA on a Ford Foundation Post-doctoral fellowship.

Shri Sanat Kaul, Joint Secretary in the Ministry of Home Affairs was affiliated to the Institute as a Visiting Scholar during the period of his fellowship awarded by Vinod Dixit Foundation.

As on 31st March, 1990, the Institute had a staff strength of 100 comprising both permanent as well as temporarily appointed hands (Annexure VIII).

FACULTY ACTIVITIES

As in the past, members of the Institute continued to participate in wide-ranging academic and allied activities both in India and abroad. They participated in seminars, symposia and conferences, delivered lectures and served on panels set up by government and also as members of academic, professional and other committees and bodies. They also rendered valuable advisory and research services to Indian and foreign organisations. The next few paragraphs sketch the notable activities of the academic staff over and above their participation in the normal research and training programmes at the Institute. Details are in Annexure III.

Dr Amaresh Bagchi, Director, as the head of the Institute continued to provide the necessary supervisory support for all research activities including projects, training programmes and seminars/ conferences of the Institute. He also personally involved himself as a member of the research teams in several of the Institute's projects in addition to looking after the Institute's affairs in all its departments. During the period under review, he continued to serve as Honorary Consultant to the Ministry of Finance, Government of India, besides being a member of several advisory panels and working groups of the Central and State governments. He was a member of the High Powered Committee (HPC) on Property Taxation set up by the Delhi Administration and headed group set up by the HPC. He was also in the working group set up by the Union Finance Ministry to review the working of the MODVAT Scheme. He also served as a member of the extended Centre for Economic Studies and Planning, Jawaharlal Nehru University.

Dr Bagchi attended a Conference on "Modern Political Economy of India" at the University of Hawaii/
East-West Center in May 1989 and presented a paper on "Debt, Deficits and Taxation in India's Government Finance". He attended a Conference on "Tax Reform in Developing Countries" convened by the
World Bank held at Washington in March 1990 and participated as a discussant of two papers presented
at the Conference and also took part in a wrap-up panel discussion. On his way back from Washington
he visited the London School of Economics, Chartered Institute of Public Finance and Accountancy, University of Bath and Inland Revenue, under the auspices of the British Council.

Dr Bagchi took active part in about a dozen national level seminars, conferences, etc. and delivered lectures at several institutions in New Delhi, Ahmedabad, Calcutta and Jainur.

Dr K N Reddy, Senior Fellow, served as a member of the panel on Economic Policy, Taxation and Incentives under the Development Council of Food Processing Industry, New Delhi. He participated in a national seminar on "Problems and Prospects of Indian Economy in Medium Term" held under the

auspices of Osmania University, Hyderabad and panel discussion on "Mid-year Review of the Economy, 1989-90" held at the India International Centre, New Delhi. He also attended a one-day seminar on "State of the Economy: Current Challenges" held under the auspices of Indian Institute of Public Administration.

Dr Reddy conducted two training programmes, one on "Fiscal Analysis and Budgetary Planning" sponsored by the Ministry of Personnel, Public Grievances and Pensions (Department of Personnel and Training), Government of India and the other on Finance and Budget for the officers of the State of Jammu and Kashmir.

Dr Reddy was the Visiting Professor at the Department of Economics, Osmania University, Hyderabad during April 1989. He delivered a series of lectures under the auspices of Osmania University on topics like issues in fiscal tederalism, appraisal of the Ninth Finance Commission, etc. He also delivered a series of lectures under the auspices of Academy of Administration, Nainital, meant for the participants of the Training Programme on Financial Management for Senior PCS Officers of the UP Government. Under the In-service Training Programme of IES Officers Dr Reddy delivered a lecture on "Centre-State Financial Relations" at the Institute of Economic Growth, New Delhi. He also lectured on "Inter-State Disparities in Educational Financing" in the training programme for District Educational Officers held under the auspices of NIEPA. Under the auspices of Department of Business Economics, Delhi University South Campus, he delivered a talk on "Reflections on 1990-91 Budget".

Dr Reddy continued to oversee the day-to-day work of the Institute in the absence of the Director.

Dr Sudipto Mundle, Senior Fellow, was on leave from the Institute from September 1989 to March 1990 and during the period of absence from the Institute, he visited Cambridge University as the First Joan Robinson Memorial Lecturer. While in the UK, he participated in a Seminar on Post-Keynesian Economics held under the auspices of University of Canterbury, Kent. He delivered a series of three lectures on sustainability of high growth in India at Free University, Amsterdam, University of Amsterdam and Erasmus University, Rotterdam and delivered another series of ten lectures on "Food, Finance and Foreign Trade: The Limits of High Growth in India "at the Universities of Cambridge, East Anglia, Glasgow, London, Oxford and Sussex. He also delivered a lecture at the Reserve Bank of India Bankers' Training College, Bombay and addressed IES Officers, IAS Officers and Senior Officers of the State Bank on topics like "Administered Prices", "Interest Rate Structure: A Review", and "Fiscal Problems and Policy in India". Dr Mundle has assumed the responsibility of editing the Institute's Newsletter.

Dr Mahesh C Purohit, Senior Fellow, conducted the 19th and 20th Advanced Training in Sales Taxation sponsored by the Ministry of Finance, Government of India. He delivered lectures on "State Level Resource Mobilisation" in the In-service Training Programme of the IES, at the Institute of Economic Growth, Delhi and 'Role of Taxation in Industrial Development", as a Foundation Programme for Probationary Section Officers at the Institute of Secretariat Training and Management.

Dr Purohit also visited Maison des Sciences de L'homme, Paris for one month in June 1989 in connection with the field work relating to "Structures and Administration of French VAT, its relevance to India". This visit was sponsored by the Paris-based institution. Dr M Govinda Rao, Senior Fellow, who was on deputation with the Ninth Finance Commission as its Economic Advisor returned to the Institute in October 1989. He presented a paper on "Intergovernmental Fiscal Transfers in India: Some Issues of Design and Measurement" at the Conference of the International Seminar in Public Economics held in January, 1990 and acted as a Discussant. He also participated in the Indian Economic Conference, chaired a session on Internal Public Debt in India and presented a Rapporteur's report. He delivered a lecture on 'Current Issues in Industrial Policy" for the participants of a programme on "Development Banking and Institutional Credit" held under the auspices of Management Development Institute, Gurgaon. Dr Rao has assumed the responsibility for conducting studies under the State Finances Unit and is looking after the production and publications unit of the Institute.

Dr Devendra B Gupta, on deputation from the Institute of Economic Growth, Delhi, since October 1987, has been holding the HDFC Chair endowed at the NIPFP, initiated several studies relating to Housing and Urban Finance. Dr Gupta also worked as member of several working groups, including the Working Group on Housing for the Eighth Plan set up by the Planning Commission, Sub-Group on Housing Needs for the Eighth Plan (Ministry of Urban Development), Working Group on Human Settlement in India (Department of Science and Technology), Working Group on Housing Statistics in India (Planning Commission) and Special Group on Water Supply and Sewerage, Ministry of Urban Development, Government of India. He also delivered lectures and coordinated seminars at several institutions and organisations including School of Planning and Architecture (SPA), Human Settlement Management Institute and Institute of Economic Growth, all based in New Delhi.

Dr Gupta attended the ESCAP/UNDP meeting on "Community-based Initiatives for Housing for Urban Poor in Asia and the Pacific", at Bangkok.

Dr B N Goldar, Senior Fellow, organised a one-day round-table on "Issues Relating to Industrial and Trade Liberalisation and Export Growth" held under the auspices of NIPFP. He also attended the Indian Econometric Conference at Aligarh where he presented a paper on "Substitution Among Labour, Capital and Energy in Selected Indian Industries" jointly with Hiranya Mukhopadhyay. He participated in a national seminar on "International Trade and Development: Implications of Recent Theoretical Research and Experience" organised by the International Trade and Development Division, School of International Studies, Jawaharlal Nehru University and presented a paper on "Liberalisation of Capital Goods Imports".

Prof Pulin B.Nayak, of Delhi School of Economics, who spent a year as Reserve Bank of India Professor, was in charge of the Direct Taxes Cell till June 29, 1989. During his tenure in the Cell, he initiated a number of projects like a pilot study on the identification of Non-Filer Potential Income Tax Payers in Faridabad, examination of the functioning of the Valuation Cell of the CBDT, taxation of fringe benefits in India, a model of personal Income Tax in India and a comparative study of Income Tax provisions in selected countries. He also gave a seminar on Welfare Economics and Public Policy at the NIPFP on June 23, 1989.

Prof Amal Sanyal who held the SBI Chair at the Institute until January 1990, completed a number of research papers two of which were presented at International Seminars abroad. One of them was on the

"Capital Market and the Indian States" presented at the Twentieth Anniversary Conference of the Journal of Contemporary Asia at Manila and the other was on "Unemployment and the Structure of Wages" (authored jointly with Professor Anjan Mukherji) presented at the Ninth World Congress of the International Economic Association at Athens. Prof Sanyal also delivered lectures at Madras Institute of Development Studies, State Bank of India Staff College and at Jawaharlal Nehru University.

Shri K N Balasubramanian, Senior Consultant, organised the symposium of Commissioners of Sales Tax/Commercial Taxes on Works Contracts and delivered a series of lectures on Concept of Sale, Taxation of Works Contracts, Hire-Purchases and Leases, problems of inter-State Sales Taxation as part of the Sales Tax Officers' Training Course.

Smt. Uma Datta Roy Choudhury, Senior Consultant, served as a Member of the UN Expert Group on the Structure of System of National Accounts (UNSSNA) and attended the meetings convened at New York and also served as a UN Consultant in Iraq. She attended the Seminar on Data Base for Poverty Studies at Ahmedabad. She also attended the Biannual Conference of the Indian Association for Research in National Income and Wealth held in Calcutta and presented a paper.

Dr Shyam Nath, Fellow, was appointed a member of the Working Group for a study of Road Transport Taxation (1990), Ministry of Surface Transport, Government of India. He attended a seminar on "Fiscal Decentralisation, Resource Mobilisation and Effective Use of National Resources for Development" sponsored by the NIPFP-ESCAP as a Resource Person. He took part in the Workshop on "Access of Urban Poor to Basic Services" organised by the School of Social Sciences, Jawaharlal Nehru University. He participated in the 27th Indian Econometric Conference held under the auspices of the Department of Economics, Aligarh Muslim University, Aligarh and presented a paper there. Dr Shyam Nath continued to be the Chairman of the Staff Council of the Institute.

Dr Arindam Das-Gupta, Fellow, took part in a meeting with Economists held under the auspices of the Ninth Finance Commission. He presented the findings of the research project on Informal Credit Markets in India sponsored by the ADB at a Workshop held in February, 1990. He prepared a paper on "An Evaluation of a Proposed Saving Scheme of the National Housing Bank" for the National Housing Bank and also prepared notes requested by the Ministry of Finance and other Ministries on specific issues from time to time. Dr Das-Gupta was a member of Library and Computer Committees and was also convenor of seminars in the Institute. After the departure of Dr Pulin Nayak Dr Das-Gupta has been assisting the Director in running the Direct Taxes Cell at the Institute.

Dr J V M Sharma, Fellow completed a major study on the Sales Tax System of Andhra Pradesh. He was also engaged in a major endeavour in building up a corporate tax model based on a sound data base which will help to simulate the impact of alternative policy regimes in corporate taxation. He gave a series of six lectures in the faculty improvement programme on panel data models. He also delivered a lecture at the Institute of Mass Communication on Resource Mobilisation and Economic Planning.

Dr Tapas Sen, Senior Economist, participated in an ESCAP-NIPFP Seminar on "Fiscal Decentralisation, Mobilisation and Effective Use of National Resources for Development* and presented a paper on "Fiscal Decentralisation in India" jointly with Dr Amaresh Bagchi, Dr. Sen also helped in organising ISPE Seminar and was engaged in setting up the Data Bank on Central and State government finances. He gave two lectures. Dr Sen was an active member of the Library and Computer Committees of the Institute.

Dr (Mrs) Rita Pandey, Senior Economist, participated in an International Conference on "Environmental Impact Analysis for Developing Countries" in New Delhi. She was associated with several studies conducted in the HDFC Unit on Housing and Urban Finance.

Dr A V L Narayana, Senior Economist, delivered a lecture on "Exchange Rate Determination" under the faculty improvement programme. Dr Narayana also delivered two lectures on India's Foreign Trade and Investment at the Indian Institute of Mass Communication. He also attended a seminar on "MODVAT to VAT" organised by FICCI in New Delhi and the International Seminar on "Public Finance" organised by the Institute. Dr Narayana assisted the Working Group on "Review of MODVAT" set up by the Central Board of Excise and Customs in New Delhi by preparing technical papers and participating in their deliberations.

Dr V B Tulasidhar, Senior Economist, was on a year's fellowship at the Department of International Health, John Hopkins University, USA.

Dr Gopinath Pradhan, Senior Economist, was also away visiting the Economics Department at Boston University, USA.

Dr Brijesh C Purchit, Economist, attended the 27th Indian Econometric Conference held under the auspices of Aligarh Muslim University, Aligarh where he presented a co-authored paper on "Local Fiscal Adjustment and State Grant Policy - An Empirical Analysis".

Dr V S Renganathan, Economist, presented a paper entitled "Liberalisation of Capital Goods Imports" co-authored with Dr B N Goldar at a national level seminar on "International Trade and Development: Implications of Recent Theoretical Research and Experience" organised by the School of International Studies, JNU, New Delhi. He also participated in a Round Table discussion on "Issues Relating to Industrial and Trade Liberalisation and Import Grants" organised by NIPFP and presented a discussion paper co-authored with Dr Goldar. He presented a background paper on "Import of Machinery and Transport Equipment - An Analysis of the Recent Measures" at the same Round Table discus-

Shri O P Bohra, Research Assistant, attended a National Seminar held under the auspices of Department of Public Administration, University of Rajasthan, Jaipur and presented a paper entitled "Water Supply, Environment and the Role of Local Government",

Details of papers and publications by faculty members are given in Annexure IV.

SEMINARS AND SYMPOSIA

An international seminar on "Fiscal Decentralisation, Resource Mobilisation and Effective Use of National Resources for Development" sponsored by ESCAP and the Planning Commission was organised by the Institute from September 5-8, 1989 in New Delhi. It was inaugurated by the then Union Minister of Planning and Programme Implementation, Shri Madhavsinh Solanki. The country papers were presented by Bangladesh, China, Indonesia, Japan, Malaysia, Pakistan, Papua New Guinea, Phillippines and Thailand besides the host country, India. Representatives from Laos, Vietnam and Nepal also took part. The country paper for India was prepared at the NIPFP by A Bagchi and Tapas Sen. The seminar provided an excellent opportunity for sharing information and experiences regarding the distribution of fiscal powers and functions of local bodies among the ESCAP region countries. It also threw up several interesting observations on administration, legislation and finances of local bodies in different countries. The proceedings of the seminar are likely to be published by the ESCAP.

As mentioned earlier, the most outstanding seminar event of the year was the conference held from January 11-13, 1990, of the International Seminar in Public Economics (ISPE), a forum founded by the renowned Prof Richard Musgrave in 1971 to hold conferences on a wide range of theoretical and applied topics in the field of public economics from time to time. The theme of the conference was "The Role of Public Finance in the Planning Process". Thirty-three renowned experts in public economics from different parts of the world participated in the conference. Fifteen papers covering various aspects of public finance were presented and discussed. There were also papers detailing the experiences of India and China on the role of public finance in planning.

The opportunity was taken by the Institute to organise a public symposium on "Trands in Tax Reform" on January 12, 1990. Prof D T Lakdawaia presided and the speakers were or Vito Tanzi, Director, Fiscal Affairs Department, IMF, Prof R M Bird, University of Toronto, Prof A Auerbech, University of Pennsylvania and Prof Nicholas Stern of the London School of Economics and Political Science. Dr Raja J Chelliah highlighted the lessons of India. A report on the symposium has been brought out.

A one-day Workshop on Informal Credit Markets in India was held at the Institute on March 14, 1990. Two reports, one on urban markets prepared at the NIPFP and the other on rural markets prepared at the Centre for Development Studies, Trivandrum were presented by the authors and discussed.

At another symposium held by the NIPFP on October 4, 1989, the implications of the Supreme Court judgement on the levy of sales tax on works contracts were discussed at length. Fifteen States and Union Territories were represented at the symposium by their Sales Tax Commissioners or other senior officers of the Sales Tax/Commercial Taxes Departments. The symposium chalked out alternative schemes of taxation of works contracts which would conform to the parameters set by the Supreme Count and at the same time avoid economic inequities or undue administrative complexities. The structural and legislative changes that might be needed in the existing schemes of taxation of works contracts operating in different States were also discussed.

The calendar of seminars/conferences of the year under reveiw opened with a seminar held jointly with the Indian Association for Research in National Income and Wealth from April 6 to 8, 1989 to discuss the proposals being considered at the international level for revision of the UN System of National Accounts (UNSNA). The UNSNA has come in for criticism particularly by developing countries as it is felt that the system does not meet their requirements and the data do not highlight the aspects of such economies relevant for an understanding of their economic behaviour and structural change. The seminar examined the recommendations from the point of view of their suitability for a country like India. A number of technical background papers were presented, one of which provided a review of all the

proposed recommendations for the revision of the SNA. The review contained proposals for a modified system of National Accounts taking into consideration the recommendations and also highlighted the transactions and other functions important for developing countries.

These apart, the Institute also held over thirty in-house seminars, symposia, etc.

RESEARCH THEMES OF PROJECTS AND STUDIES

The Institute's academic activities gathered further momentum during the year as reflected in the number of projects completed, those nearing completion and also the on-going studies. The diversity of their themes evidences a broadening of the spectrum of the Institute's research interest. Outlines of the themes of the important projects/studies are given below.

1. Aspects of Public Debt Growth in India

Professor Raja J Chelliah is conducting research on some aspects of the growth of Public Debt in India with a view to identifying the means by which the rate of growth of debt can be brought down to a more sustainable level. The long term consequences of the growth of debt would be explored and an analytical framework would be developed within which policies governing the growth of debt can be determined. He is being assisted by Shri R D Gupta and Shri K K Atri.

2. Studies and Projects under the Direct Taxes Cell

The Direct Taxes Cell has completed several research studies so far. Research completed includes theoretical and empirical examinations of some aspects of the efficiency and redistributive impact of the income tax, economic and legal examinations of specific taxation provisions, international comparisons of tax provisions and studies on administrative powers and procedures.

A major activity of this cell has been to develop computer based models of personal and corporate income taxes in order to study effect of alternative tax regimes and tax reform proposals. An initial 'Model of the Personal Income Tax' to permit estimation of the revenue and progressivity impact of changes in specific taxation or deduction provisions has been developed within the Cell. A similar model for corporate taxation is under preparation.

The development of an important comparative data set on direct tax systems in ten countries in a compilation entitled *Direct Taxes in Selected Countries: A Profile* is also another achievement of the Cell The second edition of the computation giving similar data on a number of other countries and updating the information on the first set of ten countries is also under preparation.

Research projects recently completed in the Cell are on The Exemption Limit and the Personal Income Tax: An International Comparison and Identification of Non-Filer Potential Income Tax Payers: A Study of Faridabad.

On-going studies include an examination of the functioning of the Valuation Cell of the CBDT, a study

on taxation of fringe benefits, The Income Tax Return for Salary Earners: A Proposal for Revision * and Studies in Tax Enforcement.

Another project on Taxation of Fringe Benefits in India was taken up during the year under review. However, it could not make much headway as the required information was not forthcoming.

Initiatives are under way to take up studies in the area of taxation of income of non-residents and their affiliates.

A workshop on the new assessment procedure is scheduled to be held in April** and two papers are under preparation for the purpose.

Work in the Cell is currently looked after by Dr A Bagchi with the assistance of Dr A Das-Gupta. Others closely associated with the studies undertaken in the Cell were Dr J V M Sharma, Dr Shovan Ray, Shri Rajinder Mohan, Shri Pawan Aggarwal, Shri K K Atri, Shri K Kannan, Dr Syed Peerzade, Shri P N Jhingon, Smt Vijaya Khari and Shri Navin K Singh. Prof Pulin Nayak now at the Delhi School of Economics also continued his association with the Cell and the work on the Personal Income Tax Model was started during his tenure at the Institute.

3. The State Finances Unit

A number of analytical studies of practical relevance were taken up in the State Finances Unit during the year 1989-90. Notable among them is a Study on the 'Pattern of Financing the Plans: Targets and Achievements'. The study seeks to analyse the effect of resource constraint on financing developmental plans at the State level. Specifically, the study will make a comparative analysis of the plan outlay, examine the intended pattern of financing the plans and the actual financing pattern that has eventually emerged. Research papers prepared in the Unit are circulated among the States.

A number of other important activities such as seminars and workshops are also undertaken in the Unit. One such seminar, on the "Recommendations of the Second Report of the Ninth Finance Commission" was scheduled to be held in May, 1990**.

M G Rao is now looking after the work of this Unit. Others who worked in the Unit during the year were V B Tulasidhar, K N Balasubramanian, Pallab Sarkar, H N Sahay, Dipchand Maity, Hema Papola and Sudha Mahalingam.

4. Housing and Urban Finance Unit

i. Housing as an Industry

Recently a demand has been voiced, especially by the private sector, for declaring housing as an industry. This study attempts to examine the rationale and implications of giving industry status

to housing, keeping in view the various related problems such as procurement of finance, land and building materials faced by the housing sector in the country. A preliminary draft is ready.

ii. Flow of Funds Analysis in the Housing Sector

This study sponsored by the HDFC attempts to construct a flow of funds chart with a view to ascertaining the net inflow of funds into the housing sector from the formal financial institutions. It also attempts to determine the extent of subsidy by way of soft loans for housing. The draft report is expected to be ready by February 1991.

III. Housing Finance System for the Urban Poor

This Planning Commission-sponsored study attempts to explore the form, content and extent of integration of the urban poor into the existing housing finance system. For this purpose, the present housing schemes and programmes for the poor with focus on the scrutiny of financial arrangements are being evaluated. Analysis of data was being carried out.

iv. Management Capabilities of Urban Local Bodies

The focus of the study, sponsored by the Planning Commission, is on the following:

- (a) Composition, structure and growth of tax and non-tax revenues of selected local bodies;
- (b) Scope of rationalisation and improvement in administration of existing local taxes such as property tax, octroi, etc.; and
- (c) The existing system of rates and fees charged by the local bodies and the scope for thier rationalisation.

In all, 15 sample municipalities/corporations (6 A Class, 6 B Class and 3 C Class) have been selected for the study. Data have already been collected from 12 municipalities and were being analysed. Draft report is under preparation.

v. Devolution of Funds from State Governments to Local Bodies

The basic objective of the study, sponsored by the Union Ministry of Urban Development, is to examine what could be the optimal division of functions, responsibilities and financial powers between States and Local Authorities. The study will aim at evolving a suitable formula and institutional framework for the devolution of funds from the States to local authorities to enable the latter to discharge their functions efficiently. The study will throw up a set of recommendations and suggestions for setting up an appropriate mechanism for the devolution of the funds. The field work is in progress.

vi. Water Conservation and Pollution Abatement in Indian Industry: A Study of Water Tariff

The basic objective of the study is to suggest a framework for pricing of water for industrial uses with a view to encouraging water conservation. The study is based on data collected from a

number of industrial units located along the Ganges. The report has been submitted to the Government of India.

D B Gupta was in-charge of the studies undertaken in the Unit. Others associated with the studies were Shyam Nath, Sanat Kaul, Rita Pandey and Brijesh Purohit.

5. Studies under Macro-Economics and Industrial Policy Research Programmes

i. Ettective Incentives for Aluminium Industry

The study analyses the structure of incentives for aluminium firms during the 1980s. Other aspects analysed are the effects of government price control, profitability, performance, investment behaviour and the recent deregularisation of the industry.

ii. Fiscal Policy and Growth of Firms

This study enquires into the effect of fiscal policies on the growth of firms using the Marris model. Econometric analysis is carried out using data for engineering firms.

iii. Substitution Between Energy and Non-Energy Inputs in Selected Indian Industries

Using the recently developed "cost-price" model, the study attempts to quantify substitution possibilities among energy, labour and capital in five selected energy incentive Indian industries.

iv. Studies on Industrial and Trade Policy Liberalisation

In these studies the extent and impact of recent liberalisation of industrial policies have been analysed. Also, different aspects of capital goods imports have been examined including (a) liberalisation of import policy and its effect on domestic producers, (b) pattern of growth of capital goods imports in recent years, and (c) changes in tariff rates on capital goods in the 1980s, examined in the context of substitution of quantitative restrictions on imports by tariffs

v. Determinants of India's Foreign Trade: An Econometric Analysis, 1974-75 to 1988-89

This study examines India's export growth, diversification and stability commoditywise since the mid-seventies. An econometric analysis of underlying factors shows that India's export growth has been due largely to the world income growth. The price effect due to the rupee depreciation and export incentives has only been marginal to explain export growth. The import demand, however, appears to have been consistently curtailed by the rupee depreciation and tariffs.

vi. Growth of Manufacturing Industries in India: 1975-76 to 1985-86

This paper analyses the growth of 49 major three-digit industry groups over the period 1975-76 to 1985-86. It also looks into the growth pattern in the first half of the eighties as compared to the second half of the seventies.

vii. Measurement of Import Substitution

In this study, an attempt has been made to develop a measure for import substitution, taking into account both direct and indirect imports. Using this method, the extent of import substitution has been estimated for the period 1973-74 to 1979-80.

Some other studies have been carried out on (a) inter-industry differences in growth rates, (b) India's engineering exports in the 1980s, and (c) substitution among labour, capital and energy in India's capital goods sector.

Research currently in progress under this programme includes studies on petroleum imports, exports of leather goods, gems and jewellery, capacity under-utilisation and productivity growth in Indian industry.

Studies under this programme were conducted by B N Goldar along with A V L Narayana, V S Renganathan, Hasheem Salim and Sahana Ghosh.

6. Cell on Research in Planning and Development

1. Public Finance Information System

The primary aim of the Cell which has been funded by the Planning Commission is to compile a ready-to-retrieve data bank on the finances of the Centre and the States in India. The Cell is engaged in building up **Public Finance Information System**, the first phase of which includes computerisation of budgetary data of Central and State governments from various sources. The work on computerisation of data from two sources - Indian Economic Statistics (Public Finance) and Reserve Bank of India Bulletin have been completed.

Taxable Capacity of Kerala

At the instance of the State Planning Board, Kerala, the Institute carried out a study on Tax Potential of Kerala for the Eighth Plan period. This study, instead of applying the representative tax system approach usually employed for such exercises, used the performance of Kerala itself in the recent past to derive norms for what the State can achieve in revenue raising in the next five years.

Tapas Sen was in charge of the data bank work in the Cell during the year. Others working with him were S Gopalkrishnan, Sushil Panthari, Diwan Chand, S Jebraj and Satish Kamath. The study on Kerala was done by A Bagchi and Tapas Sen.

7. Measurement of Capital Stock and Construction of Balance Sheet

Sponsored by the Industrial Development Bank of India (IDBI), the study of capital stock is designed to produce an alternative measure of present value of capital using discounted cash flow method of capitalisation of income method.

After collecting all the available data for the corporate sector at the industry level, comparable long

series have been built up for items like cash flow, capital employed, borrowings, fixed assets (gross and net), net worth, gross profits, etc. Real discount rate has also been determined using data over long period and discounted cash flow method is under use. Simultaneously work is in progress to construct balance sheet for corporate and public sectors of the country. Uma Datta Roy Choudhury has been conducting this project. She was assisted by Sujata Dutta and C Robertson.

8. Pricing of Energy Products in India

Undertaken at the instance of the Planning Commission, Government of India this study attempted to work out a set of prices appropriate for A.D. 2000 for the entire range of energy products of the commercial energy sector.

The study was conducted by Amal Sanyal in collaboration with Gopinath Pradhan and Hiranya Mukhopadhyay.

9. Working of Valuation Cell in Income Tax Department

Undertaken at the instance of Central Board of Direct Taxes this study seeks to assess the time taken by the Valuation Cell in the Income Tax Department to finalise cases referred to them. The study involved surveys at several important Income Tax charges. The surveys have been completed and the study is expected to be finalised shortly.

Kanwarjit Singh, Commissioner of Income Tax has been conducting the study in collaboration with P N Jhingon and K K Atri.

10. Country Paper for ESCAP Seminar on Fiscal Decentralisation

This paper on "Fiscal Decentralisation in India" was presented at a Seminar convened by ESCAP at New Delhi during September 1989. The paper covered inter-governmental fiscal relations both at the Centre-State and State-local government level. This paper was prepared jointly by A Bagchi and Tapas Sen.

11. Additional Excise Duty in lieu of Sales Tax

A project on "Exemption under Additional Excise Duty in lieu of Sales Tax: An Empirical Analysis of Loss of Revenue to the States" sponsored by the Ministry of Finance is nearing completion. This study is being conducted by Mahesh C Purohit.

12. Comparative Analysis of State Government Expenditures

This is a study sponsored by several State Governments. The basic objective of the study is to analyse the trends in government expenditures classified into economic and functional categories at both Central and State levels. Besides, the study will analyse the inter-State differences in the standards of public services provided and the role of inter-governmental transfers in reducing inequalities in social consumption. This study is being conducted by M G Rao. V B Tulasidhar was also associated with it.

13. Industrialising the North-Eastern Region-A Study of District Industries Centres in India

The study examines in detail the working of the District Industries Centres in the North-Eastern States of India. Interalia investigates its linkages with other development agencies at the district level. The study is based on detailed data specifically collected for the purpose from 11 sample districts. The report has been submitted to the Government of India. Devendra B Gupta and B N Goldar were the authors of this study.

14. Housing Statistics in India - A Report

This is a report of the Working Group of the Planning Commission. It examines the existing sources and nature of housing statistics in India and indicates specific steps for their improvement. This report has been submitted to the Government of India. Devendra B Gupta was closely associated with this study.

15. Report on Entry Tax

A report on the principles and practices of entry tax was submitted to the Department of Expenditure, Union Ministry of Finance as a research project of the Institute, Shyam Nath conducted the study along with Shekhar Mehta. A Bagchi also took part in it.

16. Summary Of Reports on Informal Credit Markets in India

A Summary of Reports on Informal Credit Markets in India was completed for the sponsors, Asian Development Bank. NIPFP also carried out six case studies on behalf of State Bank of India on Informal and Formal Credit. A Das - Gupta was the author of the former report. J.K. Pandey and H. Mukhopadhyay were associated with him for the latter study.

17. Saving Schi me of the National Housing Bank

The Institute undertook an evaluation of a proposed Saving Scheme of the National Housing Bank on behalf of National Housing Bank. The evaluation was done by A Das-Gupta.

18. Growth Study of Central Excise and Sales Tax Revenues

A comprehensive "Growth Study of Central Excise and Sales Tax Revenues" was completed and submitted to Central Board of Excise and Customs. AV L Narayana assisted by R C Gupta carried out the study.

19. Information System for Selected State Taxes in Gujarat

Commissioned by the Government of Gujarat, the project covers the following State taxes: Profestion Tax, Entertainment Tax, Electricity Duty, Stamp Duty and Motor Vehicles, Passengers and Goods Taxes. The main objectives of the project are to examine the existing information infrastructure supporting the present administration of individual taxes, identify the information gaps that currently impede the administration of State taxes and suggest ways in which the deficient information could be collected/ generated and suggest methods of maintaining an efficient information system for the State taxes. As a part of this project, the information system relating to Entertainment Duty, Registration Fees, Electricity Duty and Model Sales Tax Law are nearing completion. During the year, 1989-90, report on Stamp Duties was completed. The report of the study on Profession Tax was submitted in February 1989. K N Balasubramanian and S Gopalakrishnan were the principal researchers for this project.

20. A Study on India's Tariff Structure

This is a new project sponsored by the Ministry of Industrial Development. The major objects of the study are: (a) examination of the pattern of customs duty rates in the 1980s; (b) analysis of effective rates of protection; and (c) examination of impact of effective protection on industrial performance. This project is being conducted by a team led by B N Goldar. Others in the team are A V L Narayana and Hasheem Salim.

21. Sales Tax System in Andhra Pradesh

On behalf of the Government of Andhra Pradesh, the Institute undertook and completed a study of the Sales Tax System in that State. The study was conducted by J V M Sarma with Shekhar Mehta. A Bagchi was also closely associated.

22. Manipur Sales Tax

A research project on Manipur Sales Tax - Legislative Reform undertaken on behalf of the Government of Manipur was completed and sent to the State Government. The draft Sales Tax Bill prepared by the NIPFP has incorporated the recommendations made in the course of the Institute's study of the Manipur Sales Tax System. The draft was prepared by K N Balasubramanian.

23. Model Sales Tax Law

As an extension of the study relating to taxation of works contracts, hire - purchase and leasing, a project of designing a model sales tax law for the States in India was taken up and a model bill drafted, which is expected to be finalised after discussion at a symposium of Commissioners of Sales Tax/ Commercial Taxes proposed to be organised early next financial year.* K N Balasubramanian was the principal of this model.

24. Overview of Tax Systems of Indian States

This compilation is intended to be a reference book with short summaries of the taxes levied by different Indian States (other than sales tax for which a separate compilation has already been brought out). Work on this project has commenced and is likely to be completed by the end of the next financial year. Tapas Sen has undertaken the task of this compilation.

Since convened.

During the year under review, the following training programmes were organised by the Institute.

- The 19th and 20th Advanced Training Courses on Sales Tax Administration were held from 10th to 28th April and 6th to 24th November, 1989 respectively. These courses were sponsored by the Ministry of Finance and were designed to help senior and middle level officers of the Sales Tax and Commercial Taxes Departments of the States.
- Training Programme on Fiscal Analysis and Budgetary Planning was held from September 1 to 23, 1989 sponsored by the Union Ministry of Personnel, Public Grievances and Pensions (Department of Personnel and Training) in which 27 officers participated.
- Training Programme on Finance and Budget including Taxation, Fiscal Powers, Finance Commission work, etc. was held from October 16 to 20, 1989 by the same Ministry meant for the officials of Jammu and Kashmir State. 13 officers participated in the programme.

COMPUTER UNIT

During the year 1989-90, the software packages Lotus 123 (Release 2.2), Wordstar 2000 (Release 3.0) and dBase IV were added to the software library.

Shri Ajay Kumar Halen, Programmer, joined the Income-tax Department on deputation for a period of two years. Shri P Ram Kumar, Consultant and Shri K R Subramanian, Computer Assistant also left.

Shri Sushil C Panthari joined as Consultant. Harsh Kumari Talwar and Kumari Anjana Saraswat joined as Research Associate and Junior Research Associate, respectively.

System design and software development efforts continued and the Unit assisted the Cell on Research in Planning and Development with computerisation of the Public Finance Information System (PFIS). The Reserve Bank of India (RBI) Sub-System of the PFIS, covering State finances data from RBI sources, was completed. Information on the corporate sector, income-tax and other sectors in the data bank was also updated.

In addition, a payroll accounting system was developed for the Accounts Department.

Data analysis for the research projects of the Institute was carried on as before and word processing and preparation of final Reports in respect of these projects were also done.

All the PC range computer systems were severely affected by computer viruses which threatened to eliminate all data on the systems and backup devices. The computer staff tackled the problem ably with great patience and took pains to secure all the data and clean the systems and backup devices.

LIBRARY

New Acquisitions

The Institute library continued to play an important role by serving researchers in the field of Public Economics as well as tax officials. It had a collection of 18,909 publications as on 30.3.90. During the year under review, 1658 new books, reports and other publications and 319 bound journals were added to the library stock. The collection covers Public Finance, Fiscal, Commercial and Monetary Policies; Public Sector Economics; Urban Economics; Industry Studies; Planning and Development; Political Economy; Mathematics and Statistics; and Economic History.

Subscriptions to Periodicals

One hundred and sixty-six periodicals are now subscribed to by the library. These include all important journals on public economics and on general economics. Of these periodicals, 81 are from overseas including 14 subscribed to on microfiche or microfilm. In addition the library also received 54 periodicals free of cost making the total 220 journals. Six of these have been added in 1989-90.

Additions to Library Journal Holdings

The library has started purchasing back volumes of various journals either on Microfiche/Microfilm or in book form. The following journals have, so far, been acquired or are on order.

With these additions the Institute now has complete holdings of most important journals in public finance and general economics including holdings of important journals published in India.

Building a Small Collection of Statistical Sources

A number of significant statistical publications brought out by different institutions like the CSO. Planning Commission and the Ministry of Finance are now being received and steps have been implemented to streamline their regular acquisition. Attempts to obtain the remaining publications from a list of publications identified earlier continue.

Computerisation of Library Services

The library, besides regularly bringing out a current awareness publication, *Library Information Services*, Parts I & II, has started preparing a subject catalogue of library hodings. Current acquisitions by the library are being indexed with the help of subject experts using keywords derived from the *Journal of Economic Literature* classification scheme. UNESCO's CDS/ISIS software package is being used for retrieval of information and printing of catalogue cards.

Stock Verification

Stock verification was conducted during the year revealing a loss of 33 books between 1987-89. While this is below the accepted norms, steps have been taken to retrieve the loss and guard against such losses in the future.

Photocopier

A photocopier exclusively for library use has been acquired.

Visitors

As in the previous years, the researchers and officials from India and abroad continued to consult the library. In the year under report, 75 visitors made use of the library.

NIPFP PUBLICATIONS, 1989-90

The Institute brought out two Study Reports during the year under review. These are, Stimulative Effects of Tax Incentives for Charitable Contributions: A Study of Indian Corporate Sector prepared by Pawan K Aggarwal and Pricing of Postal Services in India prepared by Raghabendra Jha, M N Murty and Satya Paul. Four more study reports are now in advanced stage of production (A complete list of Institute's publications is at Annexure V).


FINANCE AND ADMINISTRATION

Committees of the Faculty/Staff

As in past years, the Committees constituted to look after specific areas, functioned to provide a mechanism for consultation and also help improve the performance of vital units. Mention must be made in this context of the Faculty Committee, the Staff Council, the Library Committee, the Computer Committee and the Canteen Committee.

Composition of the Governing Body

A list of the members of the Governing Body as on 31.3.1990 is given at Annexure VI. There was no change in the composition during the year.





Corporate Membership

As on the close of the financial year, the Institute had 15 sponsoring corporate members, 6 permanent members and 10 ordinary corporate members. During the year, M/s Escorts Limited resigned from the membership. A list of members is given at Annexure VII.

Institute's Building Complex

The construction of 9 faculty flats (including one for the Director's residence) was started during the previous year with the support of Government grant of Rs 7.05 lakh and the loan of Rs 20.00 lakh sanctioned by the Housing Development Finance Corporation. The construction work is nearing completion and the flats are expected to be ready for occupation by the end of October 1990.

Grants-in-aid from Government of India

The Institute received from the Ministry of Finance, Government of India grants of Rs 10.00 lakh for meeting its recurring expenses and Rs 14.10 lakh for meeting the additional liability due to rise in dearness allowance and the revision of the scales of pay of the Institute's core staff.

Grants Received from State Governments

During the financial year, the Institute received grants amounting to Rs. 9.30 lakh from 11 State Governments as against Rs. 7.00 lakh received from 8 State Governments during the previous year. Governments of Karnataka, West Bengal, Orissa, Jammu and Kashmir, Haryana, Maharashtra and Assam have given Rs 1.00 lakh each, Governments of Gujarat and Kerala Rs 0.75 lakh each, Government of Mizoram Rs 50,000 and Government of Meghalaya Rs 30,000.

Grants Received from Ford Foundation

During the financial year, the Institute received two grants from Ford Foundation. One amounting to US \$ 375,000 (Rs 61,77,924) was sanctioned to help establish a corpus fund at the Institute and the amount received from the Ford Foundation has to be kept invested. Income from these investments shall be used for fellowship suport to the Institute's faculty, visiting faculty, national level conferences and library development. The other grant amounting to US \$33,000 (Rs 509,259) is meant to meet the expenses of administering a post-doctoral fellowship programme.

Accounts

Statement of Accounts of the Institute for the Financial year 1989-90 duly audited by the Institute's newly appointed auditors, M/s Thakur Vaidyanath Aiyar & Co., Chartered Accountants are at Annexure IX. Some important features are as follows :-

The Institute's income has gone up by about 12% while the expenditure has increased by nearly 11%. Inspite of a higher growth in income, the year ended with an overall delicit of Rs. 1.59 lakh (as against Rs. 1.69 lakh last year). While the Institute did not face any cash delicit during the year, the deficit appearing in the Income and Expenditure Account is mainly because of depreciation provision on the Institute's assets and reflects inadequacy of income to cover the replacement needs of assets.

The Institute was able to add to its Capital Fund a sum of Rs. 61.78 lakh during the year with an endowment granted by the Ford Foundation as indicated at page 4. The Fund has to be kept invested and a part of its earnings shall be utilised for meeting expenses under specified heads and the other part of the earnings shall be ploughed back for maintaining the real value of the endowment.

Apart from inadequate provision for depreciation of assets, another matter for concern is the contingent liability on account of property tax payable to Municipal Corporation of Delhi (MCD) since 1982. The exact amount shall be known only after the reassessment of the Institute's building is completed by the MCD.
